MOST RECENT ACTIVITIES:

Appointed this spring by Virginia Governor Timothy Kaine to the *Board of Directors of the Virginia Economic Development Partnership* and recently completed a study of its international activities. Consulted with SCHEV on global studies in Virginia universities. Published two casebooks --- *U.S. National Security Law* (2009) (Intro by Senator Patrick Leahy) and *WTO Law & Litigation* (2007) (Intro by Director-General Mike Moore).
